

Despite the advent of Summer, the Feds are busy issuing RFPs, RFIs and Solicitations. Our process (a combination of an initial machine learning filter supplemented with good ole fashion manual review and research) has identified several good Opportunities, all of which are highlighted in the newsletter. Possibly the most compelling of these Opps was the following:

• The National Geospatial-Intelligence Agency (NGA) is searching for a partner to provide "daily downloads of Internet Protocol (IP) Geolocation Data and Anonymous IP Data."

In other Data News, General Motors is backing blockchain competitor to Equifax, Spring Labs, with \$23m in funding. Why does this matter to us in the Fed Data world, you ask? Well, here's what this news story says: "The initial solutions are fraud, credit and identity products. Using the Spring Protocol, it's possible to onboard customers by exchanging ID verification information without revealing personally identifiable information using attestations. Other identity platforms, such as Sovrin and uPort, also use attestations." The article goes in to say — "Spring Labs also aims to provide credit information for people who might otherwise lack a credit profile. It plans to do so by leveraging data from telecoms companies, other utilities, streaming services and insurers." Smells like potential disruption in the consumer credit world.
