- *Sources Sought - Disclosure Research Database Subscription* -- The U.S. Securities and Exchange Commission (SEC) is seeking sources for a Commercial Off the Shelf (COTS) solution that provides subscription to a database of all SEC comment and response letters publicly released. The coverage shall include all companies that file with the SEC. Attachment 1 provides the SEC's Draft Requirements List.

In other interesting and relevant news for our federal data community, the Security Solutions for Enabling and Assuring Business website published a story called "Senate Bill Would Create a National Supply Chain Security Center", which describes how U.S. Senators Mike Crapo (R-Idaho) and Mark Warner (D-Virginia) have introduced bipartisan legislation to guard against attempts by China and others to undermine U.S. national security by exploiting and penetrating U.S. supply chains.

Other components of the bill include:

- Summarizes key findings of Congress regarding supply chain security;
- Directs the Director of National Intelligence, DOD and other relevant agencies to develop a plan to increase supply chain intelligence within 180 days;
- Makes funds available under the Defense Production Act for federal supply chain security enhancements
