Carpe Datum's *deal discovery process* uncovered nine excellent solicitations that we believe are well worth your time and attention. We hope there's something there for each of you in this week's edition!

- **Industry Day - Data Science Support IDIQ – U.S. Air Force – Data Analytics:** Develop and operate data science use cases for a variety of Air Force organizations. Use cases start by understanding the decision making needs of the organization and analyzing various organization problem sets or questions. From this, algorithms or application must be identified and created to support organizational decision making. Data must be engineered and staged to feed the algorithm. Finally translate, visualize, and automate the algorithm or application to integrate with existing organizational processes and provide lasting value for the organization.

In other data news, on October 11th, the Fifth Domain reported, "Is Congress in the Dark on Supply Chain Risk?" Here's an excerpt:

- "Neither Congress nor the Judiciary has the resources, expertise or mission to replicate the IC [Intelligence Community] SCRM's [Supply Chain Risk Management] work, meaning that the comprehensive 'whole of government' approach the FASC [Federal Acquisition Security Council] was intended to achieve will likely only benefit one branch of the federal government," the senators wrote. "This leaves Congress and the court at risk of introducing insecure [information and communications technology] that is vulnerable to the national security threats assessed by IC and the FASC."
