• Request for Proposal – DoD/The Defense Human Resources Activity (DHRA), on behalf of the Joint Advertising, Market Research and Studies (JAMRS) program of the Office of People Analytics (OPA) issues this final Request for Proposal (RFP) for Survey Services and Market Research: This work requires an extensive knowledge and proven expertise in career decision-making, consumer decision-making, and marketing effectiveness theories and involves multimethod personnel research, survey planning, design and development, conducting and administering surveys...JAMRS maintains the nation's largest database of recruitment-aged youth names and contact information. The largest operational programs run by JAMRS are the Recruitment and Survey Database, and Joint Leads systems.

In other data news, on November 26st, Executive Gov's Mary-Louise Hoffman wrote an article entitled "GAO: Pentagon's Fraud Risk Mgmt Program Should Include Contractor Ownership Assessments". It features a recent GAO Report that is focused on major challenges presented to the DoD Acquisition community when trying to determine a firm's "beneficial ownership. Here's an excerpt:

• "Some companies doing business with the Defense Department have opaque ownership structures that may conceal who owns, controls, or benefits from the company. We identified fraud and national security risks to DOD from opaque ownership such as ineligible contractors receiving contracts and foreign firms receiving sensitive information through U.S.-based companies. We recommended DOD include contractor ownership in its department-wide fraud risk assessments."
