- Special Notice - **Industry Day/Sources Sought Event** issued by the **Immigration and Customs Enforcement (ICE) – Database Subscription Services** – ICE's components have a requirement for database subscription services to obtain logins for multiple users for researching and identifying people/businesses and their assets as subjects of investigations for potential arrest, seizure and forfeiture. This service is a recurring service.

In other data news, on March 1st, **Aljazeera** published a story entitled "**How China is using AI and big data to fight the coronavirus**" in which the author, Shawn Yuan, describes how authorities in China have stepped up surveillance and rolled out new artificial intelligence tools to fight the deadly epidemic of coronavirus. - "We have long believed that big data can help the government effectively forecast the development of a given epidemic, and to do that, we need to integrate the collection of the data in surveillance," said Dr Cecile Viboud, a staff scientist at National Institutes of Health's Division of International Epidemiology and Population Studies in the US. "China has a very comprehensive system of surveillance that has proven helpful in collecting the data needed."
