- Request for Information (RFI) for **DHS/Customs & Border Patrol's (CBP) Digital Forensic Laboratory Services** seeks to obtain commercially and publicly available information for situational awareness tools, technologies, and methodologies able to collect and integrate diverse data sources from heterogeneous assets into a common operational picture, and deliver real-time intelligence designed for immediate human comprehension and action. CBP's National Targeting Center (NTC) is a key component of CBP's comprehensive border security and management strategy to safeguard travelers and cargo. NTC is the point within the agency where advanced data, enterprise systems coverage, and access to law enforcement and intelligence resources is necessary to conduct vetting to identify travelers and shipments that pose the highest risk to U.S. security, economy, and public safety.

In other data news, the **Federal News Network** published an article entitled "**HUD 'moving quickly' with data-driven analysis to spend \$3B in pandemic funding**" in which the author Jory Heckman wrote about the Federal Data Strategy's one-year action plan being heavily tested within the first six weeks. Specifically, how the chief data officers tasked with getting the best real-time information in front of agency leaders quickly learned that the ultimate stress test existed right in front of them with the coronavirus pandemic.

- "In the race to get a big-picture view of the pandemic's impact on public health and the economy, the team behind the Federal Data Strategy continues to check off objectives in its 20-point timeline to build a robust data infrastructure in government before the end of the year. Agencies since March 31 have published more than 95,000 datasets to agency dashboards, while the Census Bureau has partnered with the University of Michigan to launch a portal that gives researchers access to restricted data from the federal statistical agencies."
