In other data news, on June 19th, **The Wall Street Journal** published an interesting article entitled "**IRS Used Cellphone Location Data to Try to Find Suspects**" in which the author, Byron Tau, describe how the Internal Revenue Service attempted to identify and track potential criminal suspects by purchasing access to a commercial database that records the locations of millions of American cellphones.

• "The tool provided information as to where a phone with an anonymized identifier (created by Venntel) is located at different times," Mr. Cole (a spokesman for IRS CI) said. "For example, if we know that a suspicious ATM deposit was made at a specific time and at a specific location, and we have one or more other data points for the same scheme, we can cross reference the data from each event to see if one or more devices were present at multiple transactions. This would then allow us to identify the device used by a potential suspect and attempt to follow that particular movement."
