- **Request for Information (RFI) – DoD's Defense Threat Reduction Agency (DTRA) Research & Development (RD) – SECURE SUPPLY CHAIN MANAGEMENT** – DTRA defines Supply Chain Risk Management as the systematic process of identifying, assessing, and mitigating threats, vulnerabilities, and disruptions to the agency's supply chain to maintain mission effectiveness. DTRA's objective is to seek to maintain the integrity of products, services, and technologies; ensure the uninterrupted flow of materiel and information; and provide for the efficient use of finances across the lifecycle of our programs. Including....Access "big data" analytics and data sources that can be used to illuminate illicit network members related to supply chain (i.e., operational, financial and commercial due diligence).

In other data news, on September 18th, **Center for American Progress** published an interesting article entitled "**What the Intelligence Community Doesn't Know Is Hurting the United States**" in which the authors, Katrina Mulligan, Matt Olsen, and Alexandra Schmitt, describe how the Intelligence Community (made up of the 17 federal agencies tasked with this shared mission) does not focus on understanding or measuring the value of what it produces, who uses it, for what purpose or how well its "information products" actually perform.

- "Notwithstanding its current limitations, the U.S. intelligence community makes the best decisions it can based on imperfect information. But it cannot continue to leverage partial, anecdotal information to inform decisions about the IC's future. Before the IC continues down a path to "store, process, exploit, and manage" the explosive growth of its data, it must first put in place foundational systems to collect basic business data about the intelligence it produces, who is using it, and for what purposes. Put another way, before the IC invests billions of dollars in new and existing tools and technologies, it should first invest in understanding its own business model—collecting and using data about the reach and impact of its work to make objective and data-driven decisions about where to invest scarce resources in the future."
