- “According to The Data Warehousing Institute, in the U.S. alone, bad, dirty, inaccurate or missing data is estimated to cost companies over \$600 billion a year. Without a clear data management strategy or a deep appreciation for data governance, TDWI said, no company can avoid the repercussions of bad data. Unless that issue is addressed, its impact will only increase as bad data propagates across systems, data quality continues deteriorating and the cost of cleansing complex data spirals out of control.”
