• Pre-solicitation Notice – Immigrations and Customs Enforcement (ICE), Homeland Security Investigations (HSI) -- Law Enforcement Investigative Database Subscription (LEIDS) – requires a web-based Law Enforcement Investigative Database Subscription (LEIDS) to assist the ICE mission of conducting criminal investigations that protect the United States against terrorists and criminal organizations that threaten our safety and national security; to combat transnational criminal enterprises that see to exploit America's legitimate trade, travel and financial systems. ICE investigative agents require a robust analytical research tool for its in-depth exploration of persons of interest and vehicles. There are approximately over 11,000 users on the existing contract. The procurement will combine the Investigative Database subscription and License Plate Reader Subscription.

In other data news, on November 16th, **FedScoop** published an interesting article entitled "**Air Force bases look to facial recognition to secure entry**" in which the author, Jackson Barnett, describes how two Air Force installations recently inked deals to use facial recognition technology to verify the identities of those coming on base — a move that can increase the physical distance during security checks as the coronavirus pandemic continues.

• "Many facial recognition systems have been criticized for being built with bias and giving less accurate results when identifying non-white and non-male faces, per the National Institute of Standards and Technology. TrueFace says it uses a diverse database called "Fairface," which has roughly equal sample sizes of races and genders to try and reduce the bias of its algorithms. With a more balanced database, the company says its technology develops less implicit bias and can more easily recognize non-white and non-male faces."
